

Open call for companies to apply for CIRCULAR TRANSITION SUPPORT

CirEkon (Serbia), Chamber of Commerce and Industry of Serbia (Serbia), Cleantech Bulgaria (Bulgaria), Research Centre Athens (Greece), Chamber of Commerce and Industry of Timisoara (Romania) and Wuppertal Institute (Germany) with the full support of EIT Climate – KIC are commencing with the collaboration on tackling abovementioned issues.

The combined members' market has a yearly GDP of over € 500 billion, our countries directly contribute to major international supply chains of automotive, technology, tire and rubber, packaging, food and agriculture industries... And this... is only a part of our regional CE potential.

In our countries, understanding of circular economy must go beyond recycling and towards business innovation. Implementation is falling behind our European business counterparts in almost all of our countries, regulations are of a similar setup, circular economy initiatives are at their start of development, and we intend to collectively create success stories in today's business, to catalyse CE development and implementation.

The objective for 2020 is to implement a resilient, regionally fit implementation process/framework for circular sustainable solutions into business, while directly connecting experiences from 6 Balkan countries and 2 other European countries.

How?

STEP 01 DEFINE BUSINESS CHALLENGES

We will frame your recognized challenge in a systemic, circular way. This approach shifts the focus from solving immediate issues that are usually not producing resilient solutions, towards a systemic perspective where your business is positioned within the dynamic environment and detects multiple trajectories of change. In this sense, final circular economy solutions should produce pain reliefs for 4 companies (2 in Serbia and 2 in Romania) taking in account the whole lifecycle and supply chain systemic perspective.



STEP 02 SYSTEMICALLY ANALYSE YOUR BUSINESS IN CE CONTEXT

We will distil challenges defined by systemically assessing your CE business state of play. We will analyse trends, flows, detect systemic barriers and opportunities, and define hotspots where changes should be implemented using state-of-art methods, tools and circular frameworks.

STEP 03 TRAIN YOUR STAFF FOR A SMOOTHER TRANSITION

We know that the best change is when it comes from within. We are aware of the importance of raising the staff capacity to understand, support and succeed in organizational and business changes. That is why we have to, and we will organize Education / Training process that will show your employees how to recognize, decide upon and manage circular transformation in your organization.



STEP 04 DEFINE ACTIONABLE FRAMEWORK FOR FURTHER DEVELOPMENT

Currently, CE Beacons encompass circular actors from 6 countries, we are building capacity for a detailed overview of markets, policies, needs, challenges, actors, research and innovation centres and funds.

What do we search for?

We search for companies that have recognized mainly (excess) material or energy related challenges in their processes, business systems and/or supply chains.

We also search for companies that are willing to innovate and differentiate on the market by conducting business responsibly following principles of a carbon-neutral circular economy.

Furthermore, we see that we can help innovation companies/organizations that have recognized a waste/material related gap on the market and have an almost go-to-market solution.

Finally, we would like to meet companies that are ready to co-invest in the process, with maximum € 2.500 until the end of the year 2020. This, however, is not a mandatory condition to apply for a programme.

- What do you need to know about your value chain to benchmark your CE position?
- What and how should you use the tools to navigate through the CE transition / transformation?
- What do you need to change in business (from the lifecycle perspective) to reach a future fit business?

- What do I have to take care of, from the external environment, to successfully market new products/services?

We also offer a unique comprehensive process of detailed analysis, assessment, training, investment options and action planning for your perceived circular business transition.

We finally offer you a place in our network where cutting-edge technologies, novel solutions and latest insights related to circular economy innovation will pass through, on daily basis.

- Potential for a systemic circular economic shift / enabling new circular market creation
- Novel solutions (Innovation potential)
- CO2 eq. decrease potential
- Alignment with the Romania Circular Economy Roadmap
- Alignment with the European Circular Economy Action Plan priorities
- Willingness to contribute financially

CE Beacons project will span throughout the year 2020, with most intensive collaboration perceived to be during autumn and wintertime (September–December).
